Student Responsibilities (Please Initial)

_____ With the exception of Weekend Class & Pool (Learn to Dive) and Scuba Camp, students are responsible for providing Masks, Fins & Snorkel for their class.

_____ Students are responsible for providing wetsuit, BC, & regulator for all courses except for Open Water(Learn to Dive),Scuba Review, Scuba Camp and Aquarium Diver (Aquarium students provide wetsuit). If you do not have this equipment, you can rent it from Atlantic Edge Dive Center.

_____ Students are responsible for lake entry fees for all courses, if applicable.

_____ Students are responsible for acquiring all textbooks and reading all chapters and completing all necessary knowledge reviews prior to coming to class, per the course description. The course description can be obtained at Atlantic Edge Dive Center, or on the web at www.atlanticedge.com/course_forms.html. All DVDs included in your course materials are the property of Atlantic Edge and must be returned at the conclusion of class. DVDs can be purchased for an additional fee.

_____ Scuba Diving is an in-water activity. It is required that all participants have moderate swimming ability and be comfortable in the water.

_____ For your safety and ours, Atlantic Edge reserves the right to inspect all equipment being used in the pool or during open water dives PRIOR to starting any classes. At the sole discretion of Atlantic Edge, any equipment not deemed satisfactory will not be allowed to be used. I understand that by not having equipment checked prior to the pool sessions or dives I may be turned away and required to retake the session at an additional fee.

_____ Students are responsible for having all medical forms and liability waivers completed prior to coming to their first class. The necessary forms for your class can be obtained at Atlantic Edge Dive Center, or on the web at www.atlanticedge.com/course_forms.html.

_____ Students who arrive at class without having read the appropriate coursework, completed the knowledge reviews and completed their medical forms and liability releases may be required to re-enroll in a new class. The re-enrollment fee is \$50 for all courses except Open Water Class & Pool and Aquarium, for which the fee is \$100. **Students who come to class unprepared and are rescheduled and will not be eligible to receive a refund.**

_____ Students are responsible for all transportation to and from classes. Students in classes requiring two days of training dives taking place over the weekend are responsible for lodging, if required.

_____ Enrollment in a course is not a guarantee of receiving a certification. Atlantic Edge and your instructor will do everything possible to make sure you pass all performance requirements within the allotted time for your course. In the event that you are unable to meet the performance requirements in the normal allotted time for your course, Atlantic Edge will not be able to issue you a certification and you will need to re-enroll in the course in a subsequent session at the regular course price.

_____ Students must attend all sessions for their course. If you miss any sessions of a course, you may not be able to complete the remaining sessions and you will not be eligible for a refund or a reschedule. Not attending class is not an implied cancellation— students who do not attend class will not be eligible for a reschedule or a refund.

Refund and Cancellation, and Inclement Weather Policies (Please Initial)

_____ Atlantic Edge charges a Cancellation/Reschedule fee for any course cancelled or rescheduled at *any time for any reason*(exception—see below). This fee will be equal to 25% of the Enrollment Fee for the course you are canceling/rescheduling. In the event of a cancellation, you will be charged this 25% fee as well as the retail cost of any books that were included in your registration. Not attending class is not an implied cancellation.

_____ Courses must be cancelled/rescheduled no later then Close of Business the day before the course begins. Courses cancelled or rescheduled on or after the start date are subject to a 100% cancellation/reschedule fee.

_____ From time to time, class schedules and/or venues may need to be changed due to circumstances outside of Atlantic Edge Dive Center’s control (weather, facility issues, etc.) If a class needs to be cancelled, students will have the opportunity to reschedule into another class of their choosing.
